The following resolution was offered by Alderman Elliot Doré, duly seconded by Alderman Steven Premeaux, and adopted.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, DECLARING CERTAIN POLICE UNITS NO LONGER NEEDED FOR PUBLIC USE AND DECLARING THE ITEMS AS SURPLUS PROPERTY; AUTHORIZING THE CHIEF OF POLICE TO OFFER THE UNITS FOR SALE TO OTHER PUBLIC BODIES ONLY FOR LAW ENFORCEMENT PURPOSES FOR A MINIMUM FIXED PRICE FOR EACH VEHICLE; AUTHORIZING THE HONORABLE GREG A. JONES, MAYOR OF THE CITY OF CROWLEY, TO EXECUTE AN ACT OF SALE OF THE SURPLUS POLICE UNITS TO OTHER PUBLIC BODIES OR ENTITIES FOR LAW ENFORCEMENT PURPOSES EXCLUSIVELY AT THE MINIMUM FIXED PRICE AND TO EXECUTE ALL OTHER APPROPRIATE DOCUMENTS IN CONNECTION WITH THE SALE AND TRANSFER OF THE UNITS; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the Crowley Police Department has completed the lease with option to purchase of eighteen (18) new 2015 police interceptor units which were acquired to replace aging police units; and

WHEREAS, fifteen (15) of the Police Department's units are five or more years old, have high mileage, experienced significant down time and expense for repair and are no longer needed for public use by the Crowley Police Department; and

WHEREAS, no other departments of the City of Crowley have use for the fifteen (15) used police units and it is appropriate to declare the units as surplus property; and

WHEREAS, several law enforcement agencies have expressed interest in purchasing the used police interceptors for law enforcement purposes and it is in the best interest of the City of Crowley to offer for sale the fifteen (15) used units to other public bodies or entities for law enforcement purposes at the minimum price as set by the Chief of Police; and

WHEREAS, the Chief of Police has provided an estimated value of each unit for sale to other public bodies for law enforcement purposes;

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in special session duly convened that they do hereby find the following fifteen (15) police units are five or more years old, have high mileage, significant wear and have required significant repairs, replacement units have been acquired by the City of Crowley and the following units are no longer needed for public use and are hereby declared to be surplus equipment, to-wit:

Gibson, Chief of Police of the City of Crowley, be and he is hereby authorized to offer for sale at a fixed minimum price the fifteen (15) police interceptor units listed above to other public bodies to be exclusively used for law enforcement purposes only; and

BE IT FURTHER RESOLVED that they do hereby authorize, empower and direct the Honorable Greg A. Jones, Mayor of the City of Crowley, to execute any and acts of sale for the said vehicles at the fixed minimum price specified by the Honorable K.P. Gibson, Chief of Police, transferring them to other public bodies and/or entities with the provision that they be used exclusively for law enforcement purposes.
