# CITY OF CROWLEY REGULAR COUNCIL MEETING APRIL 13, 2004

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Tuesday the 13<sup>th</sup> day of April, 2004, at the regular meeting place of said Mayor and Board of Aldermen, the City Hall, 426 North Avenue F, Crowley, Louisiana.

Mayor de la Houssaye presided with the following Aldermen present: James M. Buatt, Tiger Istre, Woody Marceaux, Vernon Martin, Mary T. Melancon, Laurita D. Pete, Steven C. Premeaux, Ira Thomas and Kitty Valdetero.

Mr. Kenneth Nutt led the Pledge of Allegiance to the flag and Alderman Martin gave the invocation.

Alderman Istre moved to amend the agenda to consider a resolution for procurement procedures for LCDBG. Seconded by Alderman Buatt and duly adopted after a unanimous vote.

Alderwoman Melancon moved to amend the agenda to consider Partial Payment No. 2 to E. L. Habetz for the Concession Complex. Seconded by Alderwoman Valdetero and duly adopted after a unanimous vote.

Alderwoman Valdetero moved to amend the agenda to consider Partial Payment No. 5 to E. L. Habetz for the Rice Interpretive Center. Seconded by Alderwoman Melancon and duly adopted after a unanimous vote.

Alderwoman Melancon moved to amend the agenda to consider the report from Tim Mader on the erosion problem of Kerney Leger's property. Seconded by Alderman Buatt and duly adopted after a unanimous vote.

Alderman Marceaux moved to amend the agenda to include the Public Hearing to fix the salary of the Director of Public Works, after the giving and posting of prior notice of said hearing in the manner provided by law. Seconded by Alderwoman Melancon and duly adopted after a unanimous vote.

Mayor de la Houssaye opened the public hearing on proposed ordinance no. 1285. The ordinance to set the salary of the Director of Public Works was read by title.

Mr. Regan asked for opponents to the proposed ordinance no. 1285. A third and final call was made with no one coming forward to speak.

Mr. Regan asked for proponents of the proposed ordinance no. 1285. There were no comments after the third and final call.

Mayor de la Houssaye called the public hearing on ordinance no. 1285 to a close.

Alderman Martin moved to dispense with the reading of the minutes of the March 4, 2004 special council meeting and approve them as written and distributed. Seconded by Alderwoman Valdetero and duly adopted.

Alderwoman Melancon moved to dispense with the reading of the minutes of the March 9, 2004 special council meeting and approve them as written and distributed. Seconded by Alderman Istre and duly adopted.

Alderwoman Valdetero moved to dispense with the reading of the minutes of the March 16, 2004 special council meeting and approve them as written and distributed. Seconded by Alderman Martin and duly adopted.

Alderwoman Melancon moved to dispense with the reading of the minutes of the April 7, 2004 special council meeting and approve them as written and distributed. Seconded by Alderman Thomas and duly adopted.

Alderman Thomas moved to approve all bills presented for payment. Seconded by Alderwoman Melancon and duly adopted.

# MAYOR'S REPORT:

Mayor de la Houssaye presented the Sales Tax Report and User Fee Report that compare current collections to collections from previous years. The Recap of all Funds Report compares actual revenues and expenditures for the seven months of the fiscal year to the budgeted revenues and expenditures of the same period.

# **STANDING COMMITTEE REPORTS**:

## PUBLIC WORKS:

Alderwoman Melancon offered a motion to accept the written proposal by Mr. Ron Sarver to correct problems in the Lawrence Acres Subdivision drainage system. Mr. Sarver will provide resident inspections of the job and will provide the city as well as Mader Engineering with all required documentation for the system to be accepted. Seconded by Alderman Thomas and duly adopted.

Alderwoman Melancon offered a motion to authorize the Mayor to enter into a contract with Le Talley Ho for Bicentennial Park Drainage Improvements Phase I in the amount of \$20,821. Seconded by Alderwoman Pete and duly adopted.

Alderwoman Melancon offered a motion to authorize Drainage Improvements on Third Street at Avenue G (Post Office) and the construction of sewerage system conflict boxes in the Downtown Parkerson subsurface drainage outfall system. These projects are to be included in the City-Wide Street Repair Contract. Seconded by Alderman Martin and duly adopted. Alderwoman Melancon offered a motion to authorize Mader Engineering, Inc. to perform the necessary survey and studies to determine the appropriate pipe size and invert elevations for the installation of pipe in the ditch along the John Greenman property on 8<sup>th</sup> Street at Eastern Avenue. Seconded by Alderman Buatt and duly adopted.

Alderwoman Melancon offered a motion to authorize the advertisement for bids for the Firemen's Training Facility Phase I and refer to Revenue and Finance. Seconded by Alderman Istre and duly adopted.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT WITH THE ACADIA COUNCIL ON AGING, INC.; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the Acadia Council on Aging is a non-profit quasi-public corporation which provides assistance to the elderly and others in need of services, such as meals, education, recreation and other services; and

WHEREAS, the Acadia Council on Aging owns and operates a facility which is located on East 1<sup>st</sup> Street which is in need of a larger and improved parking area to accommodate the elderly and the public being served by the agency; and

WHEREAS, the agency does not have adequate funds to pay the costs of improvements which are needed; and

WHEREAS, the Acadia Council on Aging, Inc. has requested assistance from the City of Crowley to provide labor, equipment and dirt to assist in the expansion and improvement of the parking area located on East 1<sup>st</sup> Street;

NOW THEREFOR BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley in regular session duly convened that they do hereby authorize, empower and direct the Honorable Isabella L. de la Houssaye, Mayor of the City of Crowley, to execute an Intergovernmental Agreement with the Acadia Council on Aging, Inc. authorizing the use of City equipment and personnel and to furnish dirt to assist in the construction and improvement of an expanded parking area located on East 1<sup>st</sup> Street to meet the needs of the elderly and others seeking services or assistance through the agency; and

BE IT FURTHER RESOLVED the said Isabella L. de la Houssaye is hereby authorized, empowered and directed to provide such assistance in her discretion, as may be necessary, to meet and proper under the circumstances to complete the improvement and expansion of the parking area.

WHEREAS, an ordinance has been proposed to be adopted by the Board of Aldermen of the City of Crowley; and

WHEREAS, the proposed ordinance must be introduced by its title; and

WHEREAS, the proposed ordinance must be referred to the Planning and Zoning Commission of the City of Crowley to hold a public hearing to consider the proposed ordinance and make recommendations to the Board of Aldermen prior to its adoption; and WHEREAS, the proposed ordinance may be considered by the Board of Aldermen for adoption after receipt by the Planning and Zoning Commission and public hearing as required by the Larson Act;

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Board of Aldermen, that the following ordinance be and it is hereby introduced for consideration to be adopted by the Mayor and Board of Aldermen, to-wit:

## ORDINANCE NO. 1286

AN ORDINANCE TO AMEND SECTION 3.1304, OF ARTICLE III OF APPENDIX A -ZONING, ORDINANCE NO. 1059 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY TO INCREASE THE HEIGHT OF FENCES, WALLS AND HEDGES TO EIGHT (8) FEET ON REAR AND SIDE YARDS; AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONTRARY THERETO AND/OR IN CONFLICT THEREWITH; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

BE IT FURTHER RESOLVED by the Mayor and Board of Aldermen, that the City Clerk shall forward a certified copy of this resolution together with a copy of the proposed ordinance to the Chairman of the Planning and Zoning Commission of the City of Crowley; and

BE IT FURTHER RESOLVED by the Mayor and Board of Aldermen, that the Planning and Zoning Commission of the City of Crowley be and it is hereby requested to hold a public hearing to consider the adoption of the following ordinance:

Alderwoman Pete offered a motion to promote James Burnett from Permanent Police Officer to Probational Corporal effective April 14, 2004. Seconded by Alderwoman Melanconand duly adopted.

### **COMMUNITY & ECONOMIC DEVELOPMENT:**

Alderman Istre offered a motion to proclaim the month of April as Donate Life Month. Seconded by Alderwoman Pete and duly adopted.

The following resolution was offered by Alderman Istre, duly seconded by Alderwoman Pete, and duly resolved and adopted.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY IN SUPPORT OF CONGRESSIONAL FUNDING OF THE LOW INCOME HOUSING ENERGY ASSISTANCE PROGRAM (LIHEAP) AND THE WEATHERIZATION ASSISTANCE PROGRAM (WAP) OF THE UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP and the Weatherization Assistance Program (WAP) were established by Congress to provide block grants to states that can be used to help low income families meet home energy costs and weatherize their homes to conserve energy and reduce further energy bills; and

WHEREAS, while LIHEAP has been re-authorized by Congress at up to \$3.4 billion per year, it has rarely been funded at more than \$2 billion; and since the program was instituted 1981, LIHEAP's inflation-adjusted buying power has sagged to 48 percent of its original size; and

WHEREAS, LIHEAP and WAP are today inadequately funded and thus incapable of addressing the growing energy assistance and conservation needs of low income families; and

WHEREAS, the formula by which the U.S. Department of Health and Human Services allocates LIHEAP grants to individual states severely discriminates against Louisiana and other southern states by favoring heating needs of people in northern states, ignoring the fact that extreme heat is as detrimental to the health and lives of people as extreme cold; and because the formula is driven by decades-old population, income and energy price data; and

WHEREAS the federal Weatherization Assistance Program must be adequately funded to reduce energy consumption and expenditures of families living in substandard, leaky, inefficient housing to improve housing conditions which is critical to dealing the blight of poverty in Louisiana.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened do hereby urge Louisiana's entire congressional delegation to advocate and support federal legislation and appropriations bills that:

- Increase national funding for LIHEAP, to at least \$3.4 billion annually, beginning in Fiscal Year 2005;
- Increase national funding for WAP to at least \$290 billion annually, beginning in Fiscal Year 2005;
- Provide for advance funding of both LIHEAP and WAP, so as to enable states to plan more efficiently the distribution of funds for bill payment assistance and weatherization assistance;
- Study the implications for families in Louisiana and other states if LIHEAP and WAP are prevented from keeping pace with growing aging populations, poverty rates and natural gas prices; and

BE IT FURTHER RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, that Louisiana's Congressional delegation be urged to join with other members of the House and Senate from the South and West in support of legislation that would rectify the regional funding biases and inequities produced by the current LIHEAP distribution formula, which deprives Louisiana families of just and needed funds and which has not been amended since 1985.

## A RESOLUTION ADOPTING PROCUREMENT PROCEDURES RELATIVE TO THE LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the City of Crowley has been awarded a Fiscal Year 2001 Louisiana Community Development Block Grant; and

WHEREAS, under the Louisiana Community Development Block Grant Program, a written procurement must be adopted which complies with the federal regulations pursuant to the Standards Governing State and Local Grantee Procurement as set forth in the Office of Management and Budget (OMB) Circular A-102, Attachment O; and

WHEREAS, the City deems it necessary and proper to comply with the requirements for maximum open and free competition for procurement transactions.

NOW, THEREFORE BE IT RESOLVED by the Board of Aldermen of the City of Crowley that the Procurement Procedures of the City of Crowley relative to the Louisiana Community Development Block Grant Program which are attached to and made a part of this resolution are to be followed by the City and any employee responsible for procurement of services, supplies, equipment or construction obtained with funds from the Louisiana Community Development Block Grant Program.

RESOLUTION OF THE MAYOR AND BOARD OF CITY OF ALDERMEN OF THE CROWLEY AUTHORIZING AN APPLICATION FOR A GRANT FROM THE LOUISIANA LITTER ABATEMENT PROGRAM TO PROVIDE FUNDING TO HIRE A LITTER REDUCTION COORDINATOR IMPLEMENT A TO LITTER ABATEMENT PROGRAM AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the City of Crowley has adopted a comprehensive Ordinance to provide for litter control and abatement in the City of Crowley; and

WHEREAS, the Ordinance provides for authority to establish a Community Service Litter Abatement Work Program for offenders, establishes a committee to address litter reduction and abatement, and has increased the penalties for littering and provides authority for sentencing offenders to community service for prescribed time in lieu of penalties; and

WHEREAS, the City of Crowley does not have adequate personnel to coordinate and maintain an effective litter abatement campaign; and

WHEREAS, the establishment of a position as Litter Abatement Coordinator will permit the reestablishment of the citizens' committee, coordination of educational activities in local schools, clubs and organizations, coordination of offenders sentenced to community service by the Courts and to develop an effective litter reduction and abatement program;

NOW THEREFOR BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened, that they do hereby authorize, empower and direct the Honorable Isabella L. de la Houssaye, Mayor of the City of Crowley, to execute an application for a grant to the Louisiana Litter Abatement Grant Program through the Department of Environmental Quality in the amount of \$13,500.00 with a local match of \$4,500.00 for the purpose of employing a Litter Abatement Coordinator for the City of Crowley to develop, coordinate and maintain a litter abatement program and activities for the City of Crowley; and

BE IT FURTHER RESOLVED that the said Isabella L. de la Houssaye, be and she is hereby authorized, empowered and directed to do any and all things necessary and execute all the documents as may be necessary and as may be meet and proper in the premises.

## ORDINANCE NO. 1285

AN ORDINANCE TO AMEND AND RE-ENACT PART 14 OF SUBSECTION B OF SECTION 2-4 OF CHAPTER 2 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY TO FIX THE SALARY OF THE DIRECTOR OF PUBLIC WORKS; AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONTRARY THERETO AND/OR IN CONFLICT THEREWITH; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, this Ordinance has been duly introduced and notice of this Ordinance and notice of public hearing having been published; and

WHEREAS, a public hearing having been held in accordance with law on the 13<sup>th</sup> day of April, 2004 at 6:00 o'clock p.m. at City Hall, Crowley, Louisiana; and

WHEREAS, it is necessary to amend the compensation of the Director of Public Works because of the retirement of the Director of Public Works and the appointment of the new Director; and

WHEREAS, it is appropriate to establish a new beginning salary for the new Director of Public Works and it is necessary to amend Section 2-4(b)(14) of Chapter 2 of the Code of Ordinances of the City of Crowley;

NOW THEREFORE BE IT ORDAINED by the Mayor and Board of Aldermen in regular session duly convened that:

SECTION 2-4(b)(14) OF CHAPTER 2 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY BE AND THE SAME IS HEREBY AMENDED AND RE-ENACTED TO READ AS FOLLOWS:

Section 1:

**Sec. 2-4.** (b) The following salaries are hereby fixed and established for each office as set forth hereunder, to-wit:

# 14) Director of Public Works

\$33,000.00

Section 2:

This Ordinance shall become effective immediately upon its adoption.

Section 3:

If any provision, part, word, section, subsection, sentence, clause, or phrase of this ordinance should be held invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance and do hereby declare the provisions hereof, to be severable, then in that event, only that particular provision, part, word, section, subsection, sentence, clause or phrase shall be deemed unconstitutional or invalid and the remaining provisions, parts, words, sections, subsections, sentences, clauses or phrases will not be affected and shall continue in full force and effect.

Section 4:

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with or in conflict herewith be and the same are hereby repealed.
