90 located at 726 East Second Street, Crowley, LA. Seconded by Alderman Martin and duly adopted.

ZONING & ANNEXATION:

After a lengthy discussion and commits from Roxie Viator, Alderman Istre moved to release the restrictions at 316 North Avenue L for Jody and Roxie Viator. Alderman Marceaux rescinded his second and the motion failed for lack of a second.

Mayor de la Houssaye reported she had taken care of the violation administratively by authorizing the city attorney to file an injunction.
