WHEREAS, the remaining term of office of the Honorable Charles R. "Bill" Williams exceeds one year; and

WHEREAS, the governing authority is required to issue a proclamation ordering such special election and specifying the dates upon which the primary and general election shall be held in accordance with Louisiana Revised Statute 18:402;

NOW THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, in regular session duly convened, that:

SECTION 1: They do hereby issue this order and notice; and do hereby call and proclaim a special primary and special general election to be held throughout the jurisdiction and within the corporate limits of the City of Crowley, Acadia Parish, Louisiana:

SECTION 2: The date of the primary election is hereby fixed for Saturday, the 20<sup>th</sup> day of October, 2001, and the date of the general election, if necessary, shall be Saturday, the 17<sup>th</sup> day of November, 2001. Said election shall be held between the hours of 6:00 a.m. and 8:00 p.m. in compliance with the provisions of the General Election Code at the designated polling places in the City of Crowley; to-wit:

Ward 6, Precinct 1 (Part) - North Crowley Middle School (Ward 1 - Crowley)

Ward 6, Precinct 3A (Part) - North Crowley Kindergarten (Ward 1 - Crowley)

Ward 6, Precinct 3B (A11) - North Crowley Kindergarten (Ward 1 - Crowley)

Ward 6, Precinct 12 (Part) - School Board Media Center (Ward 1 - Crowley)

The officers shall be designated to serve as Commissioner in Charge and Commissioners pursuant to Louisiana Revised Statute 18:434 and the compensation of said officers shall be fixed in accordance with Louisiana Revised Statute 18:424 and 18:425.

SECTION 4: Any qualified person desiring to become a candidate for such office shall file the notice of candidacy, accompanied by the qualifying fee or nominating petition as required or authorized by law with the appropriate election official in the manner and form and under the procedures and conditions provided for under the Election Code or any other applicable provisions of Louisiana Revised Statute 1950 during the period commencing on the 8<sup>th</sup> day of August, 2001 and ending on the 10<sup>th</sup> day of August, 2001 at 5:00 p.m.

BE IT FURTHER RESOLVED by the Mayor and Board of Aldermen that they do now hereby notify, authorize, request, direct and empower the Secretary of State of the State of Louisiana, the Commissioner of Elections of the State of Louisiana, the Parish Board of Election Supervisors of the Parish of Acadia, the Clerk of Court of the Parish of Acadia, the Registrar of Voters of the Parish of Acadia, and any and all other persons and officers charged with any power, function, right, duty or responsibility in conducting elections in the jurisdiction of the City of Crowley (Ward 1), Ward 6, Precinct 1 (Part), Ward 6, Precinct 3A (Part), Ward 6, Precinct 3B (All) and Ward 6, Precinct 12 (Part), Acadia Parish, Louisiana, to exercise every lawful function, do every act necessary to conduct elections, cause returns thereof to be made and in general to perform any and all related and incidental functions necessary to canvas and promulgate the results thereof, all in accordance with law.
