Alderwoman Melancon offered a motion to consider a resolution to introduce an ordinance authorizing the issuance of sewer revenue bond series 2006 of the City of Crowley to the Louisiana Department of Environmental Quality. Seconded by Alderman Buatt and duly adopted after a unanimous vote.

Alderman Istre offered a motion to accept the recommendation of Chief Gibson and employ Chris Cormier as Police Officer Provisional pending results of physical examination & drug screening effective September 26, 2006. Seconded by Alderman Buatt and duly

adopted.

Alderman Buatt offered a motion to accept the recommendation of Chief Gibson and employ Steve Comeaux as Police Officer Provisional pending results of physical examination & drug screening effective September 27, 2006. Seconded by Alderman Premeaux and duly adopted.

Alderwoman Melancon offered a motion to table the revocation of an alcohol license. Seconded by Alderman Premeaux and duly adopted.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, INTRODUCING A PROPOSED ORDINANCE AND CALLING FOR A PUBLIC HEARING CONCERNING SAME.

WHEREAS, an ordinance has been proposed to be adopted by the Board of Aldermen of the City of Crowley; and

WHEREAS, the proposed ordinance must be introduced by its title; and

WHEREAS, a public hearing must be held prior to its adoption; and

WHEREAS, the title of the proposed ordinance must be published in the official journal and the notice shall provide the time and place where the Board will consider its adoption;

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, that the following ordinance be and it is hereby introduced for consideration at the next regular meeting of the Mayor and Board of Aldermen, to-wit:

AN ORDINANCE AUTHORIZING THE ISSUANCE OF ONE MILLION THREE HUNDRED FIFTY THOUSAND DOLLARS (\$1,350,000.00) OF SEWER REVENUE BONDS, SERIES 2006 (THE "BONDS"), OF THE CITY OF CROWLEY, STATE OF LOUISIANA; PRESCRIBING THE FORM, TERMS AND CONDITIONS OF SAID BONDS; DESIGNATING THE DATE, DENOMINATION AND PLACE OF PAYMENT OF SAID BONDS; PROVIDING FOR THE PAYMENT OF PRINCIPAL AND INTEREST; SELLING SAID BONDS TO THE LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY; AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.
