AUGUST FLOODING – BEGINNING AUGUST 11, 2016

Regarding August flooding, beginning August 11, 2016 - Parishes currently **designated** in the federal disaster declaration: **Acadia, Ascension, Avoyelles, East Baton Rouge, East Feliciana, Evangeline, Iberia, Iberville, Jefferson Davis, Lafayette, Livingston, Pointe Coupee, St. Helena, St. Landry, St. Martin, St. Tammany, Tangipahoa, Vermilion, Washington and West Feliciana** parishes. Damage assessments are continuing for other parishes. This list will be updated as additional parishes are added.

STEPS TO OBTAINING RESOURCES

REGISTER WITH FEMA

To be considered for all forms of disaster assistance (individual and business), victims must first call the Federal Emergency Management Agency (FEMA) at **(800) 621-FEMA (3362)** or access online at www.disasterassistance.gov. Businesses who sustained losses in the designated parishes can begin applying for assistance today. U.S. SMALL BUSINESS ADMINISTRATION

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory, and other business assets. You can apply for loan assistance at www.disasterloan.sba.gov/ela.

INFORMATION NEEDED FOR APPLYING FOR A SBA DISASTER LOAN

- Contact information for all applicants
- Social security numbers for all applicants
- FEMA registration number
- Deed or lease information
- Insurance information
- Financial information (e.g. income, account balances and monthly expenses)
- Employer Identification Number (EIN) for business applicants
