SPECIFICATIONS FOR FURNISHING AND INSTALLING EXTERIOR DECALS ON POLICE UNITS

The City of Crowley requests proposals for the furnishing and installing of exterior decals which shall consist of cut vinyl, self-adhesive, color reflective decals to be installed on police units in positions as described below and of the colors and dimensions specified below. Exemplers of each decal are attached however the words and descriptions as specified herein shall control. All decals shall be fully warranted for a minimum of five (5) years or more.

The Exterior Decals for the Ford Tauruses and Ford Explorer SUVs shall consist of the following with the specified dimensions:

NOTE: THERE SHALL BE NO STRIPING ON ANY VEHICLES.

I. Ford Tauruses

- A) The shield/badge is shown on Exempler #1 and the placement of the shield/badge is shown on Exempler #2.
 - 1) Navy blue background with gold edging and a gold dividing line across the top at the point as depicted in Exempler #1 with the size of the letters and striping in proportion to those shown in the seal of the State of Louisiana as shown on Exempler #1. The shield dimensions shall be approximately 14” to 15” wide and approximately 18” to 20” high.
 - 2) The word “POLICE” shall be written above the gold stripe at the top of the shield in gold letters. The size of the letters and striping shall be in proportion to the size of the shield with the word “CROWLEY” below in an arch configuration with the letter “W” centered over the seal and the words “RICE CAPITAL OF AMERICA” in gold letters on either side as shown on Exempler 1 in letters proportionate to the size of the shield.
 - 3) The seal of the State of Louisiana shall be centered below the word “CROWLEY” as depicted on Exempler 1.
- B) The word “POLICE” shall be in large letters at least 3” high and 4” to 5” inches wide with a navy blue back ground and gold edging. The word “CROWLEY” is to be placed in smaller letters similar to that as shown on Exempler #2 in navy blue.
- C) The unit number of each vehicle shall be placed on the lower left front bumper on the driver and passenger sides near the front wheel wells. The unit numbers shall be navy blue as shown on Exempler #2. The unit number of each vehicle shall also be placed on the right rear lower bumper.

- D) The words “DIAL 911” shall be placed in the upper rear quarter panel on both sides near the taillight as shown on Exemplar #2. The words “Dial 911” shall be in navy blue and a minimum of 2” to 3” high and 3” to 4” wide.
- E) The telephone number “783-1234” shall be centered on the lower portion of the trunk in navy blue in letters at a minimum of 2.5” high and 3” wide as shown on Exemplar #3.
- F) The words “In God We Trust” shall be written in cursive script in navy blue centered on the trunk above the telephone number as handwritten on Exemplar #3. The letters shall be slightly smaller than the telephone number below.

II. Ford Explorers/K-9 Units

- A) The decals for the K-9 Units shall of the same size, patterns and locations as specified for the Ford Taureses with the following exceptions and/or additions:
- B) A white standard K-9 face shall be placed on each passenger side rear window as depicted on Exemplar #4 and on the rear glass as shown on Exemplar #5. The name of the K-9 shall be placed below the K-9 face in white as shown on Exemplar #4. The police department will specify the name of the K-9 at the appropriate time.
- C) The words “CAUTION K-9” shall be placed below each rear window in bright red as shown on Exemplar #3. The words “CAUTION K-9” shall also appear on the rear glass below the K-9 face in white as shown on Exemplar #5.
- D) The unit number shall be placed on the tailgate near the rear left taillight as shown on Exemplar #5 in navy blue.
- E) The words “In God We Trust” shall be on the rear of the unit on either side of the Ford emblem in an appropriate size in navy blue.
- F) The telephone number “783-1234” shall appear on the lower part of the tailgate in the same size as shown on Exemplar #5 in navy blue.
