The following resolution was offered by Alderman Clint Cradeur and seconded by Alderman Lyle Fogleman and duly resolved and adopted.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, ORDERING THE CONDEMNATION OF IMPROVEMENTS SITUATED ON LOT 14 OF BLOCK 26 OF THE SOUTH CROWLEY ADDITION TO THE CITY OF CROWLEY BEARING A MUNICIPAL ADDRESS OF 502 EAST OAK STREET, CROWLEY, LOUISIANA; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, a Condemnation Hearing was held regarding the above described property on the 6^{th} day of December, 2019; and

WHEREAS, Notice of said Condemnation Hearing date was mailed to the property owner, Add-C Inc., on November 25, 2019, via Certified Mail Return Receipt No. 70173380000069644644, which Notice was received by the property owner on November 30, 2019, as evidenced by the US Postal Service Return Receipt No. 70173380000069644644; and

WHEN AFTER considering the evidence presented and after due consideration of the circumstances and condition of the building/property and the report of the City Inspector;

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in special session duly convened that they DO HEREBY ORDER the building/structured situated on Lot 14 of Block 26 of the South Crowley Addition to the City of Crowley, being the property of Add-C Inc., bearing a municipal address of 502 East Oak Street, Crowley, Louisiana, condemned and that the property owner shall have ninety (90) days to restore the building/structure to building code requirements, which repair/renovation work shall begin within thirty (30) days from the date hereof and IT IS FURTHER ORDERED that the City Inspector shall inspect the building and/or structure within thirty (30) days of the date hereof to determine adequate work has commenced and is continuing and in the event the work is not completed within ninety (90) days from the date herein, the building/structure shall be demolished; and

BE IT FURTHER RESOLVED that the property owner shall obtain a building permit or demolition permit within seven (7) days of the date of receipt of this notice.

THUS DONE AND ADOPTED in special session duly convened on the 6th day of December, 2019, at Crowley, Acadia Parish, Louisiana, after notice thereof having been properly posted, at which a quorum was present and acting throughout.

Alderman Vernon Martin made a motion to reset these condemnations to a later date. Seconded by Alderman Byron Wilridge. Legal Counsel recommended that the last two items be deferred due to repairs being made already on 420 East Cedar Street and the fact that Mr. Wayne Dailey no longer owns 502 East Oak Street. Motion failed with a 5-2 against vote.

Alderman Sammy Reggie offered a motion to demolish 420 East Cedar Street belonging to Wayne Daily within a 30-day time frame. Seconded by Alderwoman Kim Stringfellow.

The following substitute motion was offered by Alderman Vernon Martin that the public hearing for 420 East Cedar Street belonging to Wayne Daily be suspended and that an inspection be done within 30 days. If the property is not up to code at the time of the inspection, the public hearing will be rescheduled for the next regular Council meeting. Seconded by Alderman Bard Core. Motion carried with a 4-3 vote.

The next property belonging to Paul Wayne Dailey situated on Lot 8 and the East Half Lots 9 and 10 of Block 2 of the Conway Addition to the City of Crowley bearing a municipal address of 907 West 10th Street, Crowley, Louisiana was addressed. Legal counsel, Mr. Calvin Woodruff, stated that since the property was sold and if it was recorded in the Acadia Parish Court House it will depend on when the notice was sent and the purchase was made. No action can be taken on this property.

A motion to table the action on property belonging to Paul Wayne Dailey situated on Lot 8 and the East Half Lots 9 and 10 of Block 2 of the Conway Addition to the City of Crowley bearing municipal address of 907 West 10th, Street, Crowley was made by Alderman Vernon Martin and seconded by Alderman Brad Core. Motion carried.

There being no further business to come before the Council upon motion duly made by Alderman Brad Core and seconded by Alderwoman Kim Stringfellow the meeting was adjourned at 2:46 p.m.
