### PUBLIC HEARING:

Mayor Pro Tem Steven Premeaux opened the public hearing on proposed ordinance no. 1509, the ordinance was read by title as follows:

AN ORDINANCE AMENDING THE BUDGETS FOR THE CITY OF CROWLEY FOR THE FISCAL YEAR, BEGINNING SEPTEMBER 1, 2019 AND ENDING AUGUST 31, 2020; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO; AND TO REPEAL ALL ORDINANCE OR PARTS OF ORDINANCES INCONSITENT OR IN CONFLICT THEREWITH

Mr. Steven Premeaux asked for proponents to the proposed ordinance no. 1509. A third and final call was made with no one coming forward to speak. The call for opponents of the proposed ordinance no. 1508 was made with no one coming forward to speak. No other comments were made after the third and final call. Steven Premeaux called the public hearing on ordinance no. 1509 to a close.

Vernon Martin addressed the council reading a letter he wrote regarding the new budget. City Engineer read a letter from City Attorney Tom Regan regarding the budget amendments being heard today. Desiray Seaux brought up an issue on where she doesn't believe that the public hearing notice was published due to the hurricane. A phone call from the City Attorney was received and a recommendation was given to recess the meeting until a verification of the meeting was found.

Alderman Clint Cradeur seconded by Alderman Brad Core made a motion to recess the meeting upon recommendation of the City Attorney. Motion carried and the meeting was recessed at 6:50 p.m.
