RESOLUTIONS:

The following resolution was offered by Alderman Thompson Bradford Core and seconded by Alderman Byron K. Wilridge, Sr., and duly resolved and adopted.

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE CITY OF CROWLEY, STATE OF LOUISIANA, ORDERING THE CONDEMANTION AND DEMOLITIN OF THE BUILDING/STRUCTURE SITAUTED ON LOTS 19-20, BLOCK 6, WALKER ADDITION, CITY OF CROWLEY, BEARING A MUNCIPAL ADDRESS OF 309 NORTH WESTERN AVENUE, CROWLEY, LOUISIANA, AND DECLARING SAME A GRAVE AND IMMINENT THREAT TO PUBLIC SAFETY; AND TO PROVIDE ALL MATTER RELATIVE THERETO AND IN CONNECTION THEREWITH.

WHEREAS, a Notice of Emergency Condemnation was issued by the City Inspector and Chief of Police as a result of the collapse of the roof and the bowing out of the south wall of the building/structure known as the Louisiana Foundation of Christ Sanctified Holy Church situated on Lots 19-20 of Block 6 of the Walker Addition to the City of Crowley bearing a municipal address of 309 North Western Avenue, Crowley, Louisiana; and

WHEREAS, an Emergency Inspection Report was issued by the City Inspector and Chief of Police confirming that after inspection, it was found that the south portion of the roof had collapsed, the walls were bowing in and out and the steeple/wall was leaning in and the condition of the building/structure was deemed unsafe and represents an immediate and grave threat to public safety; and due to the possibility of imminent collapse of the building/structure which threatens injury, damage or loss to persons and property and the Chief of Police and City Inspector recommended the building/structure should be condemned and ordered demolished; and

WHEREAS, the Notice of Emergency Condemnation and Emergency Inspection Report was issued and duly posted on the building at 309 North Western Avenue, Crowley, Louisiana, and served upon Glen Howie, attorney appointed to represent the absentee/unrepresented property owner, and a special meeting was called to be held 24 hours after the notice was served and posted; and

WHEREAS, considering the condition of the building/structure, the report and recommendation of the Chief of Police and the City Inspector stated above, the Mayor and Board of Aldermen find the building/structure represents a significant and grave threat to public safety and welfare;

NOW THEREFORE, BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Parish of Acadia, State of Louisiana, in special session duly convened, that they do hereby declare that the condition of the building/structure situated on Lots 19-20 of Block 6 of the Walker Addition to the City of Crowley belonging to LA Foundation of Christ Sanctified Holy Church bearing a municipal address of 309 North Western Avenue, Crowley, Louisiana, represents a grave threat to public safety and poses a substantial risk of damage, injury or loss to persons and property as a result of the imminent collapse and that the said building/structure is hereby ordered condemned and demolished immediately; and

BE IT FURTHER RESOLVED that immediate action be taken by Code Enforcement and all other authorities as may be necessary to demolish the building/structure and remove the debris therefrom forthwith; and

BE IT FURTHER RESOLVED that a certified copy of this Resolution and the Notice and Inspection Report issued and referenced herein shall be recorded in the Mortgage Records of the Clerk and Recorder of Acadia Parish, Louisiana, providing notice to all subsequent transferees of the lien for all costs incurred in connection herewith.

THUS, DONE AND ADOPTED in special session duly convened, pursuant to notice thereof duly issued, posted, and called in accordance with law in at Crowley, Acadia Parish, Louisiana, on this the 24 day of June 2021, at which a quorum was present and acting throughout.
