A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, AUTHORIZING THE RETIREMENT OF K-9 OFFICER "KELVIN"; AUTHORIZING AN AGREEMENT TO PROVIDE FOR THE CARE, CUSTODY AND CONTROL OF THE K-9 OFFICER; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, K-9 Officer "Kelvin" has provided valuable law enforcement service to the Crowley Police Department and the citizens of the City of Crowley in the performance of his duties; and

WHEREAS, K-9 Kelvin's partner, Jerry Braun has reported that K-9 Kelvin was having problems with his hind legs sometimes dragging and he appeared to be in pain; and

WHEREAS, K-9 Kelvin was examined by Dr. Katie Habetz at Acadia Animal Clinic who determined he appeared to have developed symptoms in his hind legs and neurological signs of Ataxia for which she prescribed anti-inflammatory medication along with a joint supplement and that K-9 Kelvin with several weeks of rest and recommended an MRI neurological consult; and

WHEREAS, K-9 Kelvin was seen by Dr. Arturo Otamendi, a neurological specialist, and an MRI was performed of the cervical spine which revealed narrowing of the T4-5, T5-6 and T6-7 disc spaces with concurrent ventral spondylosis; and

WHEREAS, the City of Crowley received a written report of the diagnosis by Dr. Arturo Otamendi of a spinal cord injury at C5-6 and Wobbler's disease in K-9 Kelvin's cervical spine which is a complicated disease resulting in a wobbly gait in the hind limbs, stiffness, weakness, neck pain and other difficulties; and

WHEREAS, due to K-9 Kelvin's chronic and severe diagnosis, Dr. Arturo Otamendi recommended K-9 Kelvin's immediate retirement from the Crowley Police Department; and

WHEREAS, K-9 Officer "Kelvin" has earned the right to retire from the strenuous duties of a K-9 Officer and it is appropriate to retire K-9 Officer "Kelvin"; and

WHEREAS, K-9 Officer "Kelvin" is a live canine but is technically an asset owned by the City of Crowley and is considered a member of the Crowley Police Department and it is necessary to provide for his continued care, custody and control during his retirement until his death because of his training as a "Canine Enforcement Officer"; and WHEREAS, the City of Crowley does not have an appropriate or suitable facility and/or means to provide for the K-9 during his retirement and the sale and/or transfer of the K-9 Officer to third parties is problematic due to his law enforcement training and the relationship with his partner/handler, Jerry Braun; and

WHEREAS, Jerry Braun is a police officer of the City of Crowley and has expressed his desire to accept the ownership and responsibility of caring for his long-time partner, "Kelvin", as a result of his close association and has agreed to accept the care, custody and control of the K-9 Officer "Kelvin" as a trained and experienced K-9 handler and to assume full responsibility and liability and to hold harmless and indemnify the City of Crowley thereafter; and

WHEREAS, all equipment necessary for the handler to control of the K-9, including kennel, collars, leashes, vests, etc., should also be transferred to Jerry Braun;

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened that they do hereby officially acknowledge and commend K-9 Officer "Kelvin" for his years of dedicated service to the Crowley Police Department and the citizens of Crowley and do hereby officially retire K-9 Officer "Kelvin" from active duty with the Crowley Police Department; and

BE IT FURTHER RESOLVED that they do hereby authorize the transfer of ownership, possession and control of the animal include the transfer and use of all equipment necessary for the control of the K-9, including kennel, leashes, collars, vests, etc.; and

BE IT FURTHER RESOLVED that they do hereby authorize, empower and direct the Honorable Tim Monceaux, Mayor of the City of Crowley, to execute an agreement with police officer Jerry Braun transferring the possession, custody, control and responsibility for the care and ownership of K-9 "Kelvin" to the said Jerry Braun together with the kennel, collar, leashes and other such equipment in consideration of his relationship with K-9 "Kelvin" as his long time partner and trained K-9 handler in consideration of the acceptance of the responsibility to care for and control the K-9 and indemnify the City of Crowley for same; and

BE IT FURTHER RESOLVED that said agreement shall contain the following terms and conditions: 1) Jerry Braun shall accept the custody of and responsibility for the safety and well-being of the K-9 "Kelvin" as well as the safety and well-being of all persons and property; 2) Jerry Braun

shall not transfer, sell or donate or place the animal with anyone else or use the animal for any commercial purposes, enterprise or profit; 3) Jerry Braun agrees to provide K-9 "Kelvin" with all necessary care including but not limited to shelter, food and veterinary service for the rest of his natural life at his expense; 4) Jerry Braun agrees to provide a secure facility/structure which will at all times provide an adequate means of containing, sheltering, controlling and protecting the animal and persons from injury; 5) Jerry Braun shall agree to assume all liability and responsibility for K-9 "Kelvin" and to indemnify and hold harmless the City of Crowley from any and all claims, demands, causes of action, lawsuits which may arise out of or occur while K-9 "Kelvin" is in the possession, care, custody and control of Jerry Braun; and 6) all usual and necessary terms and conditions as may be required in the premises.

THUS DONE AND ADOPTED in regular session duly convened on the 9th day of November, 2022, in Crowley, Acadia Parish, Louisiana, at which a quorum was present and acting throughout.
