## CITY OF CROWLEY REGULAR MEETING JUNE 15, 2023

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 6:00 p.m. Wednesday the 15<sup>th</sup> day of June 2023 at the regular meeting place of said Mayor and Board of Aldermen, the Council Chambers, 426 North Avenue F, Crowley, Louisiana.

Mayor Chad Monceaux presided with the following Aldermen present: Chuck Ashby, Katie Chiasson, Thompson Bradford Core, Jeff Doré, Vernon Martin, Sandy Marx, Samuel J. Reggie III, and Byron K. Wilridge, Sr. Alderman Dickie Latiolais was absent.

Alderman-at-Large Chuck Ashby gave the invocation. Chief of Police Troy Hebert led the Pledge of Allegiance to the flag.

# **PUBLIC HEARING:**

Mayor Chad Monceaux suspended the agenda of the Regular Council Meeting and opened a public hearing for Proposed Ordinance No. 1537.

AN ORDINANCE TO AMEND ARTICLE I, CHAPTER 12 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, BY ADDING THERETO SECTION 12-15 ESTABLISHING THE BASE PAY OF POLICE POLICE OFFICERS AND DEPARTMENT PERSONNEL AND AUTHORIZING A MINIMUM TWO PERCENT (2%) ANNUAL SALARY INCREASE FOR POLICE OFFICERS OF ALL RANKS AFTER THREE (3) YEARS CONTINUOUS SERVICE AND THEREAFTER, A TWO-PERCENT (2%) ANNUAL SALARY INCREASE FOR EACH ADDITIONAL YEAR OF SERVICE UP TO AND INCLUDING TWENTY (20) YEARS; TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES CONTRARY THERETO OR IN CONFLICT THEREWITH; TO PROVIDE FOR THE PROVISIONS HEREOF TO BE SEVERABLE; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

City Attorney Thomas Regan called for proponents. A second and final call was made with no one coming forward.

City Attorney Thomas Regan then called for opponents. A second and final call was made with no one coming forward.

Mayor Chad Monceaux called the hearing to a close.

Mayor Chad Monceaux resumed the agenda of the Regular Council Meeting.

A motion was offered by Alderman Jeff Doré and seconded by Alderwoman Sandy Marx to recommend approval of Partial Payment Estimate No. 18 under the Glenn Lege' Construction, LLC contract for the City-Wide Drainage Improvements (contract A) Project in an amount of \$233,868.86. Motion carried.

A motion was offered by Alderman Jeff Doré and seconded by Alderman-at-Large Chuck Ashby to recommend approval of Partial Payment Estimate No. 13 to Glenn Lege' Construction, LLC for the City-Wide Street Improvements (Contract B) Project in the amount of \$372,547.75. Motion carried.

A motion was offered by Alderman Jeff Doré and seconded by Alderwoman Sandy Marx to recommend the adoption of a resolution authorizing the preparation of specifications and the letting of bids for FY 2023-2024 Internal Television Inspection for Storm Drainage and Sanitary Sewer Systems Contract for the period September 1, 2023 through February 29, 2024. Motion carried.

A motion was offered by Alderman Jeff Doré and seconded by Alderman Thompson Bradford Core to recommend the adoption of a resolution declaring portion of Recycled Asphaltic Pavement (RAP) material surplus and authorizing Mayor Chad Monceaux to determine the appropriate selling price and procedures to offer and sell surplus RAP to the public. Motion carried. Mr. Jason Montz voiced his opinion on using excess RAP.

Alderwoman Sandy Marx abstained from the vote. Motion carried.

A motion was made by Alderman Byron K. Wilridge, Sr. and seconded by Alderwoman Sandy Marx to recommend authorizing Tracy Young and the Rotary Club use of the Rice Festival Building on September 16, 2023 at no cost for the "Rise Against Hunger" Program. Motion carried.

#### **ORDINANCES:**

A motion was made by Alderman Thompson Bradford Core and seconded by Alderman Vernon Martin to adopt Ordinance No. 1537; motion carried; Ordinance No. 1537 was duly adopted.

#### ORDINANCE NO. 1537

AN ORDINANCE TO AMEND ARTICLE I, CHAPTER 12 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, BY ADDING THERETO SECTION 12-15 ESTABLISHING THE BASE PAY OF POLICE OFFICERS AND POLICE DEPARTMENT PERSONNEL AND AUTHORIZING A MINIMUM TWO PERCENT (2%) ANNUAL SALARY INCREASE FOR POLICE OFFICERS OF ALL RANKS AFTER THREE (3) YEARS CONTINUOUS SERVICE AND THEREAFTER, A TWO-PERCENT (2%) ANNUAL SALARY INCREASE FOR EACH ADDITIONAL YEAR OF SERVICE UP TO AND INCLUDING TWENTY (20) YEARS; TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES CONTRARY THERETO OR IN CONFLICT THEREWITH; TO PROVIDE FOR THE PROVISIONS HEREOF TO BE SEVERABLE; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, the governing authority of each municipality with a population of 12,000 or more

shall establish minimum rates of pay of police officers in accordance with the grades, ranks and classes of the Classified Service; and

WHEREAS, the Fiscal Year 2023 annual budget of the City of Crowley has been amended to provide an increase in the base pay of the lowest ranking full-time police officer to Thirty-Six Thousand & 00/No (\$36,000.00) Dollars annual or One Thousand Three Hundred Eighty-Four & 62/100 (\$1,384.62) Dollars per pay period; and

WHEREAS after ninety (90) days of service, the pay of a police patrol officer and other positions of the Classified Police Service will increase by Five Hundred & No/100 (\$500.00) Dollars per month, however, this increase shall not be included in the base; and

WHEREAS, it is intended that this increase in base pay shall be effective as of June 18, 2023 and that the base as set forth herein shall continue in effect in the Fiscal Year 2024 Budget beginning September 1, 2023, and each succeeding Fiscal Year Budget thereafter beginning September 1 of each successive year; and WHEREAS, it is necessary that step increases for each higher rank, position, grade or class be provided in the base pay of each rank, position, grade or class as required under LA R.S. 33:2212(B); and

WHEREAS, the step increases for the higher ranks, positions, grades or classes of the Classified Police Service shall be as follows: Corporal -5%; Sergeant -10%; Lieutenant -15%; Captain -25%; and

WHEREAS, the classified positions of police officers include the Secretary, Record Clerk and Dispatcher for which an increase in base pay must be established effective June 18, 2023; and

WHEREAS, it is necessary to increase the base pay of the secretary, record clerk and dispatcher as follows: Secretary - \$1,384.62 per pay period (\$36,000.00 annual); Record Clerk - \$1,238.92 per pay period (\$32,211.92 annual); Dispatcher - \$1,238.92 (\$32,211.92 annual) effective June 18, 2023; and

WHEREAS, the annual salaries of higher-ranking police officers of the Crowley Police Department is significantly less than the average salaries paid to comparable ranks of personnel/members of the Crowley Fire Department; and

WHEREAS, the difference in salaries of higher-ranking police officers has occurred because all members of the Crowley Fire Department Classified Service receive a 2% annual salary increase which the City of Crowley is mandated to provide by State Statute; and

WHEREAS, current State Law does not mandate all municipalities to provide a two percent (2%) annual raise to members of the Classified Service of police departments except those municipalities specifically named in the statute; and

WHEREAS, the difference in salaries paid to Crowley police officers has caused police officers to resign from the Crowley Police Department for better paying jobs with other police departments which offer significantly higher starting salaries than those paid to members of the Crowley Police Department; and

WHEREAS, the difference in salaries of police officers also affects the recruiting of officers for the City of Crowley and has reduced applications for police officer recruits to the City of Crowley; and

WHEREAS, in order to maintain parity with the annual increases mandated to be received by the classified members of the Crowley Fire Department, the City of Crowley has the authority to authorize by ordinance a mandatory two percent (2%) annual salary increase which is equal to the annual salary increase of members of the Classified Service of the Crowley Fire Department; and

WHEREAS, the Board of Aldermen of the City of Crowley find it is in the best interest of the City of Crowley that an annual salary increase be mandated in the future so that Police Department personnel can be assured they will receive an annual two percent (2%) salary increase which will maintain parity with the salary of the members of the Classified Service of the Fire Department; and

WHEREAS, the Board of Aldermen specifically declare their intent that this Ordinance shall be prospective in its application and there is no intent nor shall this Ordinance create any right to retroactive or backpay for police officers of any rank or other members of the Classified Police Service, whether full or part time; and

WHEREAS, this Ordinance was duly introduced and notice of this Ordinance and of the public hearing having been published in accordance with law; and

WHEREAS, a public hearing having been held in accordance with law in regular session on the 15<sup>th</sup> day of June, 2023, at 6:00 o'clock p.m. at Council Chambers in the Criminal Justice Building, Crowley, Louisiana; and

WHERAS, after considering same, the Board of Aldermen declare it is in the City's best interest to amend the Code of Ordinances of the City of Crowley to establish the base pay for all ranks of the Classified Service of the Crowley Police Department and provide for a two percent (2%) annual salary increase for officers after three (3) years of service;

NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, IN REGULAR SESSION DULY CONVENED, THAT:

SECTION 1: Article I, Chapter 12 of the Code of Ordinances of the City of Crowley be and the same is hereby amended to add thereto Section 12-15 to read as follows, to-wit:

#### Sec. 12-15. Base pay for police officers; annual salary increase.

(A) Base Pay

(1) Effective June 18, 2023, the base pay for the following positions and ranks of the Classified Service of the Crowley Police Department shall be as follows, to-wit:

(a) The base pay for the position of Record Clerk shall be One Thousand
Two Hundred Thirty-Nine & 15/100 (\$1,238.92) Dollars per pay period or Thirty-Two Thousand
Two Hundred Seventeen & 90/100 (\$32,211.92) Dollars annually.

(b) The base pay for the position of Police Dispatcher shall be One Thousand Two Hundred Thirty-Nine & 15/100 (\$1,238.92) Dollars per pay period or Thirty-Two Thousand Two Hundred Seventeen & 90/100 (\$32,211.92) Dollars annually.

(c) The base pay for the position of Classified Secretary shall be One
Thousand Three Hundred Eighty-Four & 85/100 (\$1,384.62) Dollars per pay period or Thirty-Six
Thousand Six & 10/100 (\$36,000.00) Dollars annually.

(d) The base pay for Police Patrol Officers shall be One Thousand Three
Hundred Eighty-Four & 62/100 (\$1,384.62) Dollars per pay period or Thirty-Six Thousand & 12/100
(\$36,000.00) Dollars annually.

(2) For the positions of Corporal, Sergeant, Lieutenant and Captain, the minimum percentage of separation in base pay for each higher rank from the base pay of Police Patrol Officer shall be as follows, to-wit:

- (a) Corporal Five (5%) Percent;
- (b) Sergeant Ten (10%) Percent;
- (c) Lieutenant Fifteen (15%) Percent;
- (d) Captain Twenty-Five (25%) Percent

(3) Effective June 18, 2023, the base pay for the following positions and ranks of the Classified Service of the Crowley Police Department above Police Patrol Officer shall be as follows, to-wit:

(a) The base pay for Corporal shall be One Thousand Six Hundred Eighty Four & 63/100 (\$1,684.63) Dollars per pay period or Forty-Three Thousand Eight Hundred & 38/100
(\$43,800.38) Dollars annually.

(b) The base pay for Sergeant shall be One Thousand Seven Hundred Fifty-Three & 87/100 (\$1,753.87) Dollars per pay period or Forty-Five Thousand Six Hundred & 62/100 (\$45,600.62) Dollars annually.

(e) The base pay for Lieutenant shall be One Thousand Eight Hundred
Twenty-Three & 11/100 (\$1,823.11) Dollars per pay period or Forty-Seven Thousand Four Hundred
& 86/100 (\$47,400.86) Dollars annually.

(f) The base pay for Captain shall be One Thousand Nine Hundred Sixty-One & 59/100 (\$1,961.59) Dollars per pay period or Fifty-One Thousand One & 34/100 (\$51,001.34)
Dollars annually.

(B) Annual salary increase.

(1) Effective the 1<sup>st</sup> day of September, 2024, each member of the Classified Service of the Police Department of the City of Crowley who has had three (3) years continuous service shall receive an increase in annual salary of two (2%) percent, and thereafter, shall receive an increase in annual salary of two (2%) percent for each year of additional service up to and include twenty (20) years or from year three (3) to year twenty-three (23) of service.

(2) Both the base pay and career longevity shall be used to compute the longevity pay.

(3) For those officers whose current base pay plus longevity pay exceeds the amount of base pay established from the effective date hereof, they will nevertheless be entitled to a salary increase commensurate with their rank equivalent to the salary increase for the base pay used to establish the aforesaid base pay for Police Patrol Officers.

SECTION 2: This Ordinance shall become effective the 18<sup>th</sup> day of June, 2023 and shall be applied prospective only and shall not be considered to have any retroactive effect whatsoever, including but not limited to creating or changing any amounts due for retroactive or back pay to members of the Classified Service of the Crowley Police Department.

SECTION 3: If any provision, part, word, section, subsection, sentence, clause or phrase of this ordinance should be held invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance and do hereby declare the provisions hereof to be severable, then in that event, only that particular provision, part, word, section, subsection, sentence, clause or phrase shall be deemed unconstitutional or invalid and the remaining provisions, parts, words, sections, subsections, sentences, clauses or phrases will not be affected and shall continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances inconsistent with or in conflict herewith be and the same are hereby repealed.

SECTION 5: This ordinance shall go in effect June 15, 2023.

# A RESOLUTION AUTHORIZING AN EXTENSION OF THE EXISTING CONTRACT WITH E.L. HABETZ BUILDERS, INC. THROUGH AUGUST 31, 2024 FOR THE "<u>FY 2020 - 2021</u> LABOR AND EOUIPMENT CONTRACT".

WHEREAS, the existing contract with E.L. Habetz Builders, Inc. was competitively bid in July & August 2020, and

WHEREAS, the low bid of a \$1,700 daily rate was less than half that of each of the other three bids received at that time (\$3,500/day, \$3,680/day, and \$4,500/day), and

WHEREAS, for that reason the contract with E.L. Habetz Builders, Inc, was first extended for the period of March 1, 2021 through August 31, 2021, extended again for the period of September 1, 2021 through

February 28, 2022, extended again for the period of March 1, 2022 through August 31, 2022 and extended again

for the period of September 1, 2022 through August 31, 2023, and

WHEREAS, current construction market conditions are experiencing significant inflationary increases and are expected to bring a significantly higher daily rate than \$1,700/day, and taking new bids at this time will likely lead to much higher overall bids, and

**WHEREAS**, the Mayor and Council wish to avoid the costs of preparing specifications and the bid process with the likelihood that new bid prices will be significantly higher than the existing daily rate of \$1,700.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Board of Aldermen of the City of Crowley that the E.L. Habetz Builders, Inc. existing contract for <u>"FY 2020 - 2021 LABOR AND EOUIPMENT CONTRACT"</u>, as modified by Change Orders <u>1 (One)</u>, <u>2 (Two)</u>, <u>3 (Three)</u> and <u>4 (Four)</u>, is hereby extended through August 31, 2024.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, DECLARING A PORTION FO THE RECYCLED ASPHALTIC PAVEMENT (RAP) MATERIAL PRODUCED DURING CONSTRUCTION OF **CITY-WIDE** THE 2021 STREET IMPROVEMENTS CONTRACTS A AND B PROJECTS TO BE SURPLUS MATERIAL; AUTHORIZING MAYOR CHAD MONCEAUX TO DETERMINE AN APPROPRIATE SELLING PRICE FOR SAME AND TO DEVELOP AND EXECUTE PROCEDURES TO OFFER AND SELL RAP TO THE GENERAL PUBLIC; AND TO PROVIDE FOR ALL MATTERS RELATIVE THERETO.

WHEREAS, under public works construction contracts with Glenn Lege' Construction, L.L.C., for the "2021 City-Wide Street Improvements (Contract A)" and the "2021 City-Wide Street Improvements (Contract B)" projects, Recycled Asphaltic Pavement material, commonly referred to as "RAP", is being produced by a process of grinding or milling existing asphaltic concrete street surfaces at various locations where needed throughout the City; and

WHEREAS, RAP is a stone-like, small aggregate material known to be very useful when recycled and applied for maintenance of streets, road shoulders, driveways and other applications that benefit the public for which limestone would otherwise need to be purchased at great expense; and

WHEREAS, under the aforementioned contracts, RAP is being produced in very large amounts; and

WHEREAS, the City Engineer has estimated that the current stockpile of RAP on City property located along Jack Mitchell Drive amounts to nearly 13,000 cubic yards of material; and

WHEREAS, the City Engineer has estimated 13,000 cubic yards of RAP could last 40 to 50 years, based on available figures regarding the more recently experienced annual amounts of aggregate purchased for maintenance purposes throughout the City; and

WHEREAS, in order to declare a certain volume of the RAP to be in excess of the City's needs and to allow the sale of surplus material as no longer needed by the City, the Board of Aldermen considered information provided by the City Engineer, the Street Department Commissioner, the Public Works Director, the Wastewater Superintendent and the Recreation Director after examining records of historical purchases of material aggregate used annually by City Departments; and

WHEREAS, reserving a portion of the stockpile of RAP material for City use over the next 20 years and selling the surplus portion as a significant revenue generating endeavor is believed to be in the best interest of the City; and

WHEREAS, after considering such information and the volume of RAP material on hand, the needs of the City and as a potential for a new revenue source for the City and in order to allow such sale and move forward with the sale of RAP, it is necessary for the City to declare a certain volume of the RAP to be in excess of the City's needs and surplus material and that same is no longer needed fur public purposes;

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, in regular session duly convened find the City has on hand approximately 13,000 cubic yards of Recycled Asphaltic Pavement material (RAP) derived from the "2021 City-Wide Street Improvements (Contract A)" and the "2021 City-Wide Street Improvements (Contract B)" projects which is an excess amount that would be on hand for approximately 40 to 50 years based on the most recently amounts of aggregate purchased annually used for maintenance purposes throughout the City and that it is reasonable to reserve a portion of the said RAP material for use by the various City departments which represents an estimated life expectancy based on historical evidence for approximately 20 years of average use; and

WHEREAS, K-9 Officer "Breach" can no longer perform the strenuous duties of a K-9 Officer and it is appropriate to retire K-9 Officer "Breach"; and

WHEREAS, K-9 Officer "Breach" is a live canine but is technically an asset owned by the City of Crowley and is considered a member of the Crowley Police Department and it is necessary to provide for his continued care, custody and control during his retirement until his death because of his training as a "Canine Enforcement Officer"; and

WHEREAS, the City of Crowley does not have an appropriate or suitable facility and/or means to provide for the K-9 during his retirement and the sale and/or transfer of the K-9 Officer to third parties is problematic due to his law enforcement training and the relationship with his partner/handler, Aaron Bertrand; and
