A) A RESOLUTION OF THE BOARD OF ALDERMEN OF THE CITY OF CROWLEY IN SUPPORT OF LEGISLATION IN CREATING THE ACADIANA REGIONAL JUVENILE JUSTICE DISTRICT PROVIDING FOR A POLITICAL SUBDIVISION GOVERNED BY A BOARD OF COMMISSIONERS BASED ON THE FLORIDA PARISHES JUVENILE JUSTICE DISTRICT LEGISLATION; AND TO PROVIDE ALL MATTER RELATIVE THERETO AND IN CONNECTION THEREWITH.

AN ORDINANCE TO AMEND AND RE-ENACT ARTICLE I OF CHAPTER 12 OF THE CODE OF ORDINANCES OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, BY ADDING THERETO SECTION 12-15 TO REQUIRE ALL PERSONNEL EMPLOYED AS A PERMANENT PEACE OFFICER OF THE CROWLEY POLICE DEPARTMENT TO REIMBURSE THE CITY OF CROWLEY FOR THE TOTAL COSTS INCURRED AND EXPENDED FOR LAW ENFORCEMENT EDUCATION AND TRAINING COURSES, INCLUDING BASIC FIREARMS TRAINING, FOR A PERIOD OF TWO (2) YEARS; TO PROVIDE FOR THE PROVISIONS HEREOF TO BE SEVERABLE; TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT THERETO OR IN CONFLICT THEREWITH; AND TO PROVIDE FOR ALL OTHER MATTERS RELATIVE OR PERTAINING THERETO.

C) A RESOLUTION OF THE BOARD OF ALDERMEN OF THE CITY OF CROWLEY AUTHORIZING A STANDBY LETTER OF CREDIT TO BE ISSUED BY THE FIRST NATIONAL BANK OF LOUISIANA ON BEHALF OF THE CITY OF CROWLEY FOR THE BENEFIT OF THE LOUISIANA OFFICE OF WORKERS' COMPENSATION IN AN AMOUNT NOT TO EXCEED \$300,000.00; AND TO AUTHORIZE A NON-REVOLVING LINE OF CREDIT UP TO \$300,000.00 EVIDENCED BY A PROMISSORY NOTE IN THE AMOUNT OF THE LETTER OF CREDIT; TO AUTHORIZE THE PLEDGE OF AN UNENCUMBERED CERTIFICATE OF DEPOSIT AS SECURITY FOR THE STANDBY LETTER OF CREDIT; AND TO PROVIDE ALL MATTER RELATIVE THERETO AND IN CONNECTION THEREWITH.
