RESOLUTION OF THE MAYOR AND BOARD OF ALDERMAN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, ADOPTING ART III. SOURCE SELECTION AND CONTRACT FORMATION SUBPART A. METHODS OF SOURCE SELECTION FOR THE PURCHASE OF USED EQUIPMENT

**WHEREAS**, the City of Crowley follows the Public Bid Law for the purchase of moveable equipment—La. R.S. 38:2212.1; and

WHEREAS, La. R.S. 38:2212.1 makes no provision for the purchase of used equipment exceeding the cost of \$30,000 without following the quote and/or bid processes provided in the Public Bid Law which can result in the loss of opportunity to purchase high-quality used equipment; and

WHEREAS, Title 39, Part III. Source Selection and Contract Formation, Subpart A. Methods of Source Selections, particularly La. R.S. 39:1600(C), provides an alternative method to purchase used equipment without the necessity of bids if the purchase of the used equipment is cost effective; and

**WHEREAS,** R.S. 39:1554(E)(1) authorizes political subdivisions to adopt any part of Title 39 and accompanying regulations regarding purchases; and

**WHEREAS**, the City of Crowley has an immediate need for (4) four available used, high-quality pickup trucks, but placing the purchase for bids is impracticable and would likely result in the loss of opportunity to purchase same;

**NOW THEREFORE**, BE IT RESOLVED, by the Mayor and the Board of Alderman of the City of Crowley, in regular session, duly convened, that

- 1. The City of Crowley will specifically adopt and utilize Louisiana Revised Statute Title 39, Section 1600(C), for the purchase of five (5) high-quality pickup trucks as it has been determined that the purchase of five (5) high-quality used pickup trucks is more cost effective than the purchase of five (5) new pickup trucks.
- 2. The city staff responsible for purchasing five (5) high quality pick trucks has presented the desired vehicle and has certified the following:
  - a. the price for which five (5) used pickup trucks may be obtained is in the range of \$100,000:

- b. the plan for maintenance and repair of the vehicles and the cost thereof has been explained;
- c. the savings that will accrue to the city because of the purchase of the five (5) used pickups has been explained;
- d. the fact that following the formal procedures set out in the Public Bid Law will result in the loss of the opportunity to purchase the vehicles.
- 3. Because such a certification has been presented and accepted, the purchase of five (5) suitable, high-quality pickup trucks for an amount not to exceed \$ 100,000.00 is hereby approved.
- 4. This resolution shall remain in effect until the described five (5) pickup trucks are purchased and delivered to the city, at which time the adoption of the forgoing Part, Subpart and Statute shall sunset.

THUS, DONE AND ADOPTED in regular session duly convened on this the 16<sup>th</sup> of December, 2024 at Crowley, Acadia Parish, Louisiana.

Monceaux opened the floor for discussion. There being no remarks from the Council. The resolution having been submitted to a voice vote; the resolution was carried unanimously.

A RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CROWLEY, ACADIA PARISH, LOUISIANA, **MAYOR** TO **ENTER** AUTHORIZING THE **AGREEMENT** WITH ENDEAVOR, COOPERATIVE ACADIA PARISH TOURIST COMMISSION AND THE ACADIA PARISH POLICE JURY FOR THE PURPOSE OF ASSIGNING TO THE TOURIST COMMISSION THE CITY'S RIGHT TO TAKE POSSESSION OF, MAINTAIN, PRESERVE AND ACT AS THE CURATOR OF CERTAIN ARTIFIACTS DONATED AND/OR LOANED TO THE CITY AND POSSESSED NOW OR FORMERLY BY IT AT THE RICE MUSEUM TOGETHER WITH ALL RIGHTS OF THE CITY UNDER ANY AND ALL DONATIONS, LEASES OR OTHER AGREEMENTS ENTERED INTO BY THE CITY FOR SAID PURPOSE IN EXCHANGE FOR THE ACADIA PARISH TOURIST COMMISSION ASSUMING ALL OF THE CITY'S OBLIGATIONS UNDER SUCH AGREEMENTS.

WHEREAS, the city of Crowley (hereinafter the "City"), by various written donations, other written agreements and manual gifts has taken possession of certain items of historical significance (hereinafter the "Artifacts"), for the purpose of maintaining and preserving the Artifacts and to celebrate the history and story of the rice industry by exhibiting the Artifacts;

WHEREAS, in furtherance of that endeavor the City entered into a lease agreement with the Acadia Parish Police Jury (hereinafter the "Police Jury") for the lease of the premises located at 1528 W. 2<sup>nd</sup> St. Crowley, LA 70526 (the "Acadia Parish Rice Museum");

WHEREAS, the Acadia Parish Tourist Commission (hereinafter the "Commission") has expressed an interest in taking over the City's role as the curator of the Artifacts;

WHEREAS, the City has determined that the Commission is better suited to assume the City's role as the curator of the Artifacts and desires to assign to the Commission its right to act as the curator of the Artifacts and the rights inuring to its benefit under any donations, leases, or other agreements entered into for said purpose and the Commission desires to assume the City's obligations as curator of the Artifacts including its obligations under any donations, leases, or other agreements entered into by the City for said purpose;

WHEREAS, the City, the Police Jury and the Commission desire to enter into a cooperative endeavor agreement for the purpose of affecting and facilitating said assignment;

NOW THEREFORE BE IT RESOLVED by the Mayor and Board of Aldermen of the City of Crowley, Acadia Parish, Louisiana, that the City of Crowley enter into a cooperative endeavor agreement with the Acadia Parish Police Jury and the Acadia Parish Tourist Commission for the purpose of assigning all of the City's rights as the curator of the Artifacts to the Tourist Commission including any and all rights inuring to its benefit under any donations, leases, or other agreements entered into for the purpose of taking possession of the Artifacts and exhibiting same at the Acadia Parish Rice Museum and/or elsewhere in exchange for the Commission assuming all of the City's obligations under such agreements.

**BE IT FURTHER RESOLVED** that Mayor Chad Monceaux be and he is hereby authorized and empowered for and in the name of the City of Crowley to execute any and all documents reasonably necessary or advisable to carry out said purpose including but not limited to Cooperative Endeavor Agreements and Assignments of Leases and other contractual rights upon such additional terms and conditions as the said Mayor Chad Monceaux deems advisable in his discretion.

THUS DONE, SIGNED AND ADOPTED in regular session duly noticed and convened on the 17th day of December, 2024, in Crowley, Acadia Parish, Louisiana at which a quorum was present and acting throughout.

There being no further business to come before the Council upon motion duly made by Alderman Brad Core and seconded by Alderman Chuck Ashby the meeting was adjourned at 5:59 p.m.
