

CITY OF CROWLEY
REGULAR MEETING
JANUARY 20, 2026

The Mayor and Board of Aldermen of the City of Crowley, Louisiana, the governing authority of the City of Crowley, met in a regular session at 5:00 p.m. Tuesday the 20TH day of January 2026 at the regular meeting place of said Mayor and Board of Aldermen, the Council Chambers, 426 North Avenue F, Crowley, Louisiana.

Mayor Chad Monceaux presided with the following Aldermen present: Katie Chiasson, Dickie Latiolais, Thompson Bradford Core, Jeff Doré, Samuel J. Reggie III, Byron K. Wilridge, and Sandra Marx.

Alderman Dickie Latiolais, Alderman Chuck Ashby were absent.

Alderman Vernon Martin came in during the vote for the agenda amendments.

Alderman Bryon Wilridge gave the invocation. Alderman Jeff Dore led the Pledge of Allegiance to the flag.

AGENDA AMENDMENTS:

A motion was made by Alderwoman Sandra Marx to amend the agenda to add the renewal of 2026 Beer and Liquor license of six (6) businesses under The Public Safety committee section seconded by Alderman Jeff Dore. Mayor Monceaux opened the floor for the discussion. There being no further discussion from the Council.

READING & APPROVAL OF MINUTES:

Alderman Vernon Martin moved to dispense with the reading of the December 16, 2025, Regular Council meeting seconded by Alderman Bryon Wilridge and duly adopted.

MAYOR'S REPORTS:

Mayor Monceaux presented the Sales Tax chart and User Fee chart that track the collection trend.

Mayor Monceaux presented the status report of audit findings for fiscal year 2024.

Mayor Monceaux presented the monthly budget-to-actual comparisons through December 31, 2025.

COMMITTEE REPORTS:

UTILITY COMMITTEE:

A motion was made by Alderwoman Sandra Marx and seconded by Alderman Jeff Core to approve Partial Payment #2 to Spinks Construction, Inc for the Renovation of the Existing Duckweed Pond with Modular Insulated Cover project in the amount of \$162,019.84. Mayor Monceaux opened the floor for discussion. There being no remarks from the Council. The motion having been submitted to a voice vote; Alderman Dickie Latiolais and Alderman Chuck Ashby were absent; the motion was carried.

A motion was made by Alderwoman Sandra Marx and seconded by Alderman Brad Core to approve the Final Change Order #1 to Spinks Construction, Inc. for th “renovate the Existing Duckweed Pond with Modular Insulated Cover” project in an decrease in the contract amount of \$12,502.80. Mayor Monceaux opened the floor for discussion. There being no remarks from the Council. The motion having been submitted to a voice vote; Alderman Dickie Latiolais and Alderman Chuck Ashby were absent; the motion was carried.

A motion was made by Alderwoman Sandra Marx and seconded by Alderwoman Katie Chiasson to approve the adoption of a resolution of Termination and Notice of Termination for the Spinks Construction, Inc. for the “Renovate the Existing Duckweed Pond with Modular Insulated Cover” project. Mayor Monceaux opened the floor for discussion. There being no remarks from the Council. The motion having been submitted to a voice vote; Alderman Dickie Latiolais and Alderman Chuck Ashby were absent; the motion was carried.

RESOLUTION

A resolution authorizing and directing the Mayor to execute for and on behalf of the City of Crowley, a *Notice of Termination* for Spinks Construction, Inc., Contractor, pertaining to the completion of the contract for **"Renovate Existing Duckweed Pond With Modular Insulated Cover"** in accordance with the plans and specifications contained in the contract documents pertaining thereto.

WHEREAS, a final inspection on the above referenced project was performed on January 7, 2026 and the remaining work items identified at that time have been completed; **and**

WHEREAS, Spinks Construction, Inc., as Contractor, has substantially completed the **"Renovate Existing Duckweed Pond With Modular Insulated Cover"** project in accordance with the plans and specifications contained in the contract documents pertaining thereto; **and**

WHEREAS, the City of Crowley desires to accept the completed work;

NOW, THEREFORE, BE IT RESOLVED by the City of Crowley that the Mayor of said City be, and is hereby empowered, authorized and directed to execute a *Notice of Termination* for and on behalf of the City of Crowley accepting the work as being substantially completed, and that he be authorized and directed to have a copy of said Notice recorded in the Conveyance Records of the Parish of Acadia, State of Louisiana.

ZONING & ANNEXATION COMMITTEE:

A motion was made by Alderman Samuel Reggie and seconded by Alderwoman Sandra Marx to approve Partial Payment #2 to CO-D Construction of La., LLC. for the “Drainage Improvements for Lawrence Acres & VFW Drive” project in the amount of \$253,235.38. Mayor Monceaux opened the floor for discussion. There being no remarks from the Council. The motion having been submitted to a voice vote; Alderman Dickie Latiolais and Alderman Chuck Ashby were absent; the motion was carried.


COMMUNITY & ECONOMIC DEVELOPMENT COMMITTEE:
